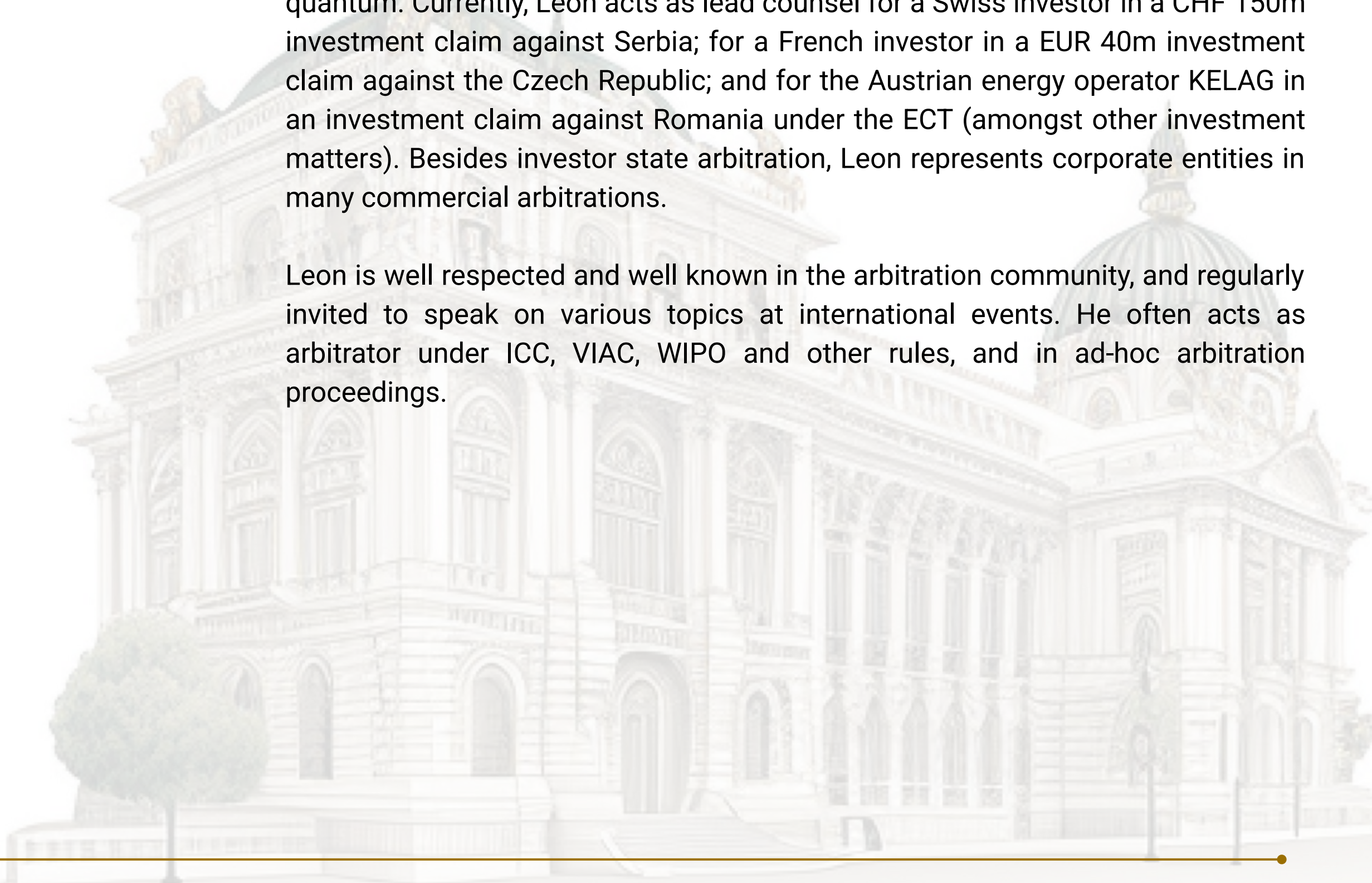
### Mr. LEON KOPECKÝ

Leon Kopecký is a partner in Schoenherr's Vienna office. Before joining Schoenherr, Leon practiced international arbitration at Freshfields and Skadden in London, New York, and Vienna.

With Leon as lead counsel, Schoenherr recorded several victories in high-profile investment cases, including in an ICSID dispute of a Cypriot investor against the Republic of Serbia, where Leon's client prevailed on jurisdiction, merits and quantum. Currently, Leon acts as lead counsel for a Swiss investor in a CHF 150m investment claim against Serbia; for a French investor in a EUR 40m investment claim against the Czech Republic; and for the Austrian energy operator KELAG in an investment claim against Romania under the ECT (amongst other investment matters). Besides investor state arbitration, Leon represents corporate entities in many commercial arbitrations.

Leon is well respected and well known in the arbitration community, and regularly invited to speak on various topics at international events. He often acts as arbitrator under ICC, VIAC, WIPO and other rules, and in ad-hoc arbitration proceedings.

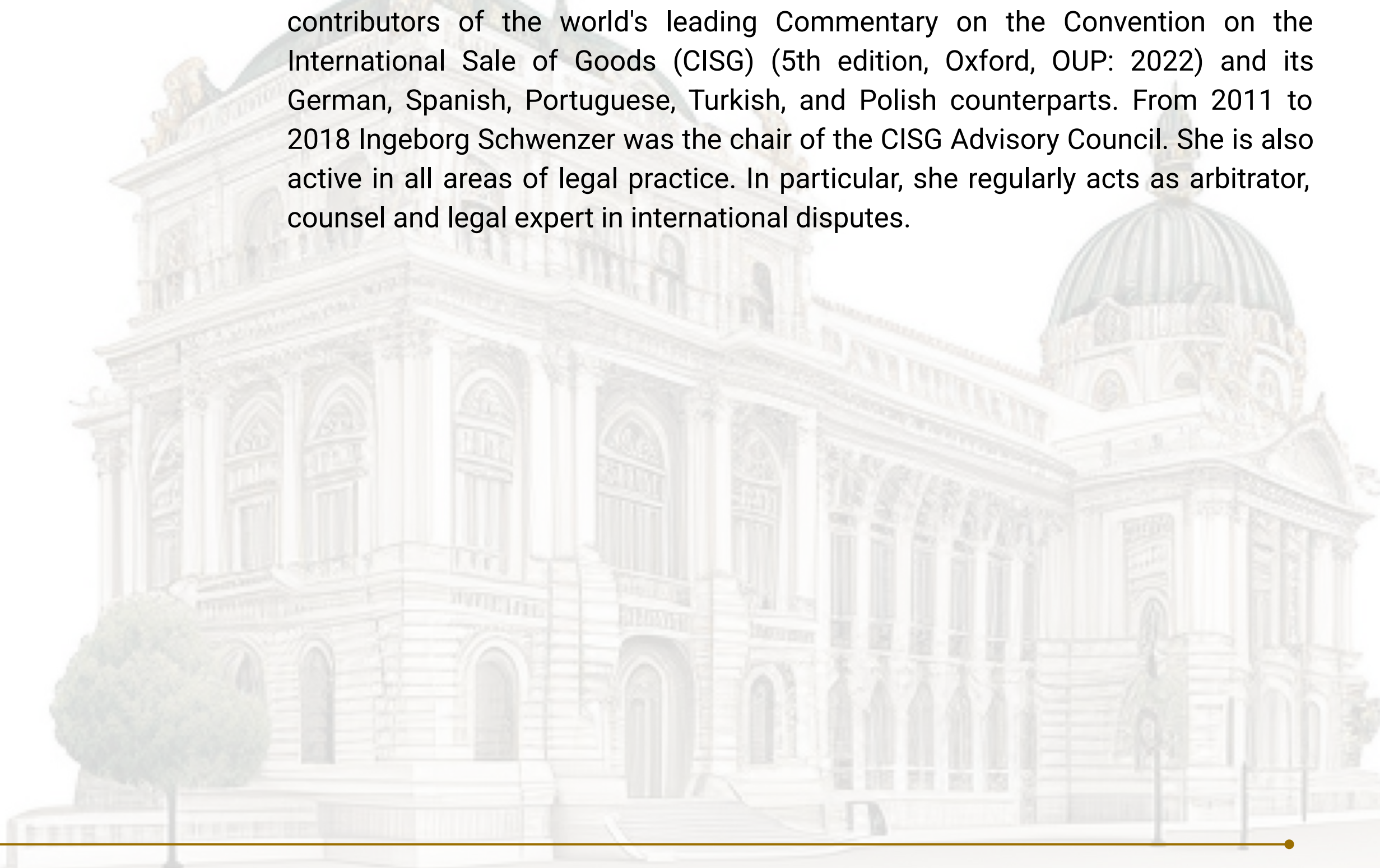

## **Prof. INGEBORG SCHWENZER**

Professor (em.),  
University of Basel

Prof. Ingeborg Schwenzer is Professor emerita of Private Law at the University of Basel, Switzerland, and former Dean of Swiss International Law School. Additionally, she is an adjunct professor at Bond University, Gold Coast, Australia, and has been an adjunct professor at City University, Hong Kong, and at Griffith University, Brisbane, Australia. She has published numerous books and more than 200 articles in the fields of law of obligations (contracts, tort law and unjust enrichment, sales law both domestic and international), commercial arbitration as well as family law. In particular, she is the co-editor and one of the main contributors of the world's leading Commentary on the Convention on the International Sale of Goods (CISG) (5th edition, Oxford, OUP: 2022) and its German, Spanish, Portuguese, Turkish, and Polish counterparts. From 2011 to 2018 Ingeborg Schwenzer was the chair of the CISG Advisory Council. She is also active in all areas of legal practice. In particular, she regularly acts as arbitrator, counsel and legal expert in international disputes.

Edgardo Muñoz is a Professor at Universidad Panamericana's School of Law in Mexico. Beyond his academic responsibilities, he has acted as an arbitrator and counsel in numerous arbitral proceedings across different jurisdictions and legal systems.

Prof. Muñoz's academic journey includes law studies in Mexico (Lic. Iur. UIA) and France (DEUF, Lyon III), followed by two Master of Laws (LL.M.) degrees—one from the University of Liverpool, UK, and another from the University of California, Berkeley, USA. He also holds a Doctor of Laws (Ph.D.), summa cum laude, from Basel University, Switzerland.

Dr. Muñoz has held positions as a Visiting Professor and Scholar at the University of Turin, Italy, Columbia University Law School in New York, McGill University School of Law, and the University of Montreal School of Law in Canada. He is a Member of VIS East Moot Foundation, the ICC World Commission on Arbitration and ADR, the General Council of Mexico's Arbitration Center, the CISG Advisory Council, the ITA Academic Council, and serves as a Correspondent of UNIDROIT in Mexico.

He also regularly publishes in the field of international business law, comparative law of obligations, international arbitration and sports law. He is admitted to practice law in California, the United States and Mexico.

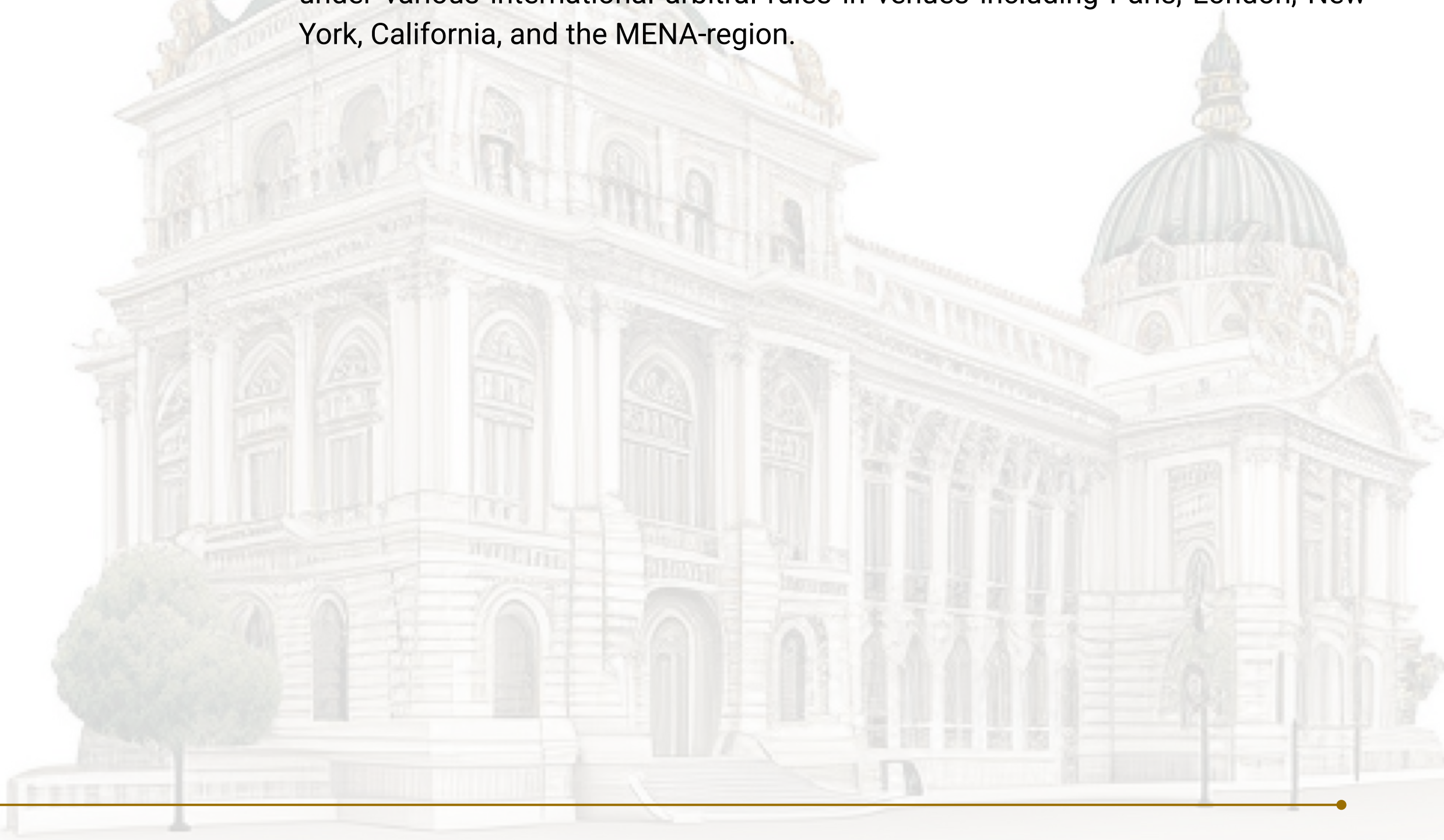

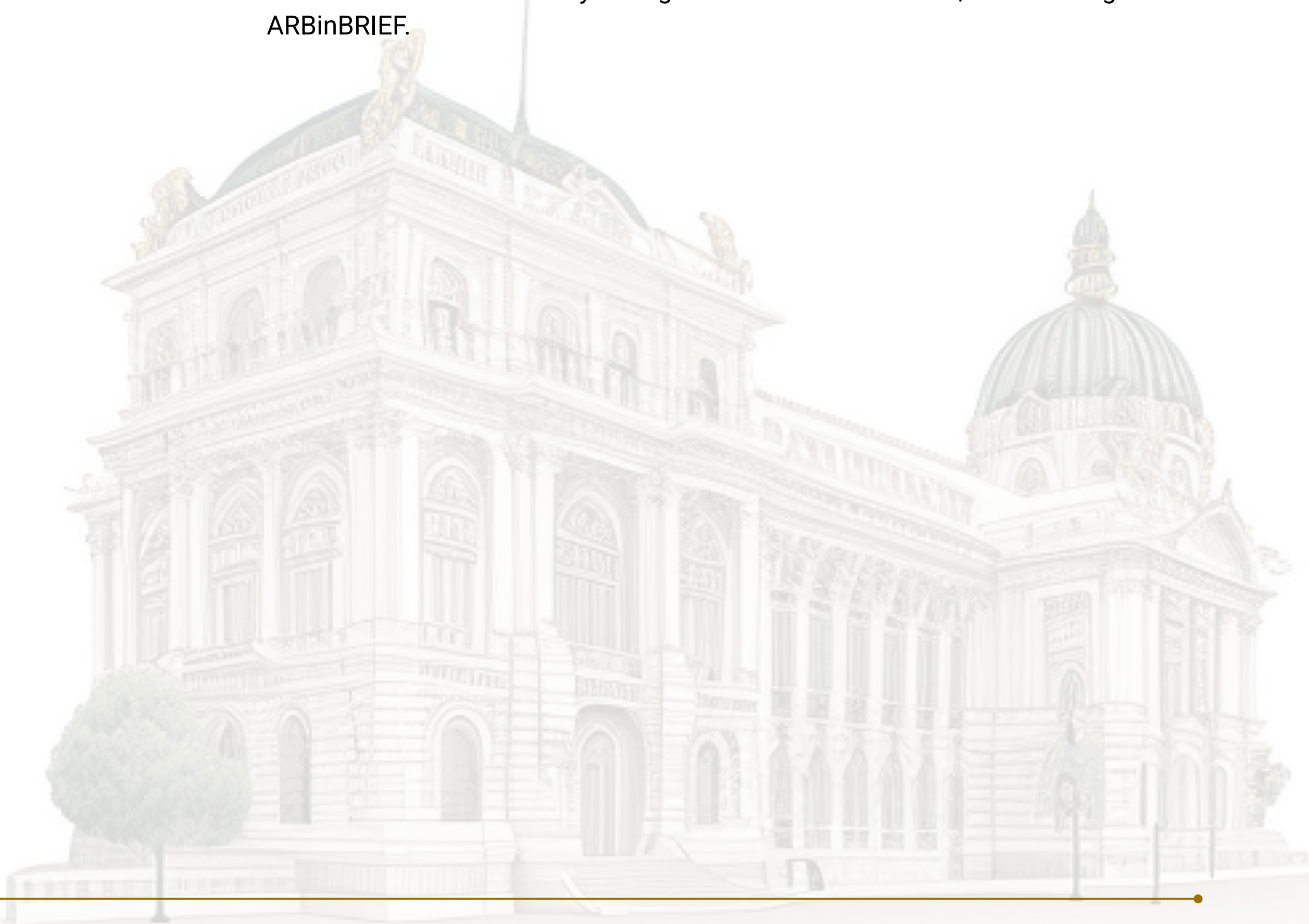

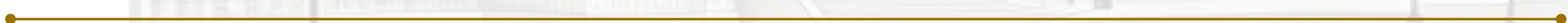


## Mr. HENRIK SAJAKORPI

Lauro Gama Jr. graduated from the State University of Rio de Janeiro (UERJ) in 1987 and was admitted in 1988 to the Brazilian Bar. He holds a Masters in International Relations (PUC-Rio, 1992), a LL.M degree in Comparative Law (McGill, 1999), and a Doctorate degree in International Law (Univ. São Paulo, 2004). He is currently Adjunct Professor at the Pontifical Catholic Univ. of Rio (PUC-Rio), where he teaches Private International Law, Contracts and International Commercial Arbitration. He has authored books and articles published in specialized journals. He participated in the working group of the UNIDROIT Principles (2008-2010) and also in the working group of the 2015 Hague Principles. A member of the CISG Advisory Council, he acted as rapporteur of CISG Advisory Opinion no. 17 on Limitation and Exclusion Clauses. In 2016, Lauro lectured at the Hague Academy of International Law (“The UNIDROIT Principles as the law applicable to commercial contracts”, published in vol. 406 of the Collected Courses). To this date Lauro has acted as counsel and arbitrator in more than 120 cases, under the rules of ICC, LCIA, UNCITRAL and Brazilian arbitral institutions. Mr. Gama has served as President of the Brazilian Arbitration Committee (CBAr) from 2013 to 2015, and as a Member of the ICC Court of International Arbitration from 2015 to 2021. He is currently a Council Member of the ICC Institute of World Business Law and a member of the working group of the ICC-UNIDROIT project on international investment contracts.

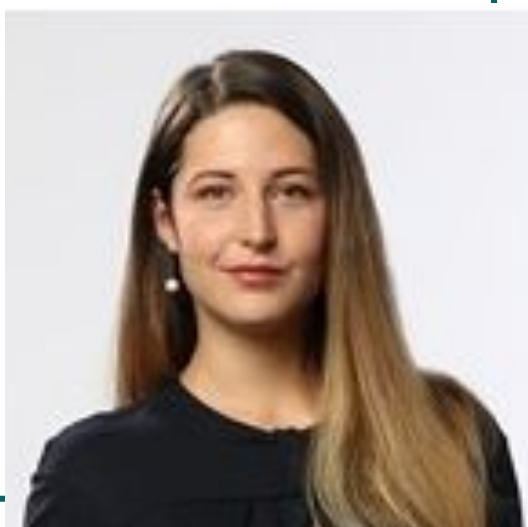

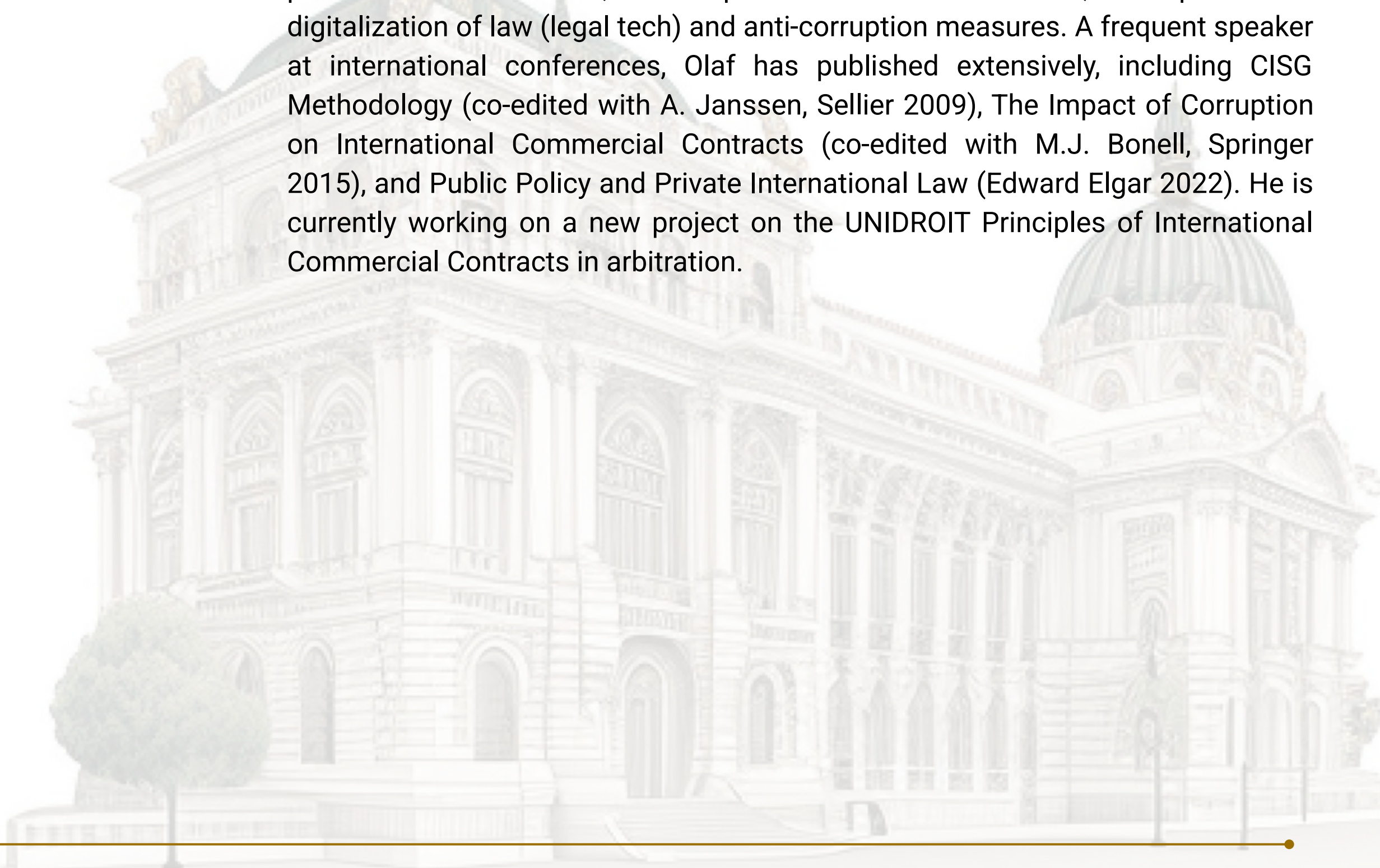

## **Prof. OLAF MEYER**

Professor of Contract Law,  
Frankfurt University of Applied Sciences

Olaf Meyer is a Professor of Contract Law at the Frankfurt University of Applied Sciences. He earned his doctorate from the University of Münster, obtained a master's degree from the University of Oxford, and completed his habilitation at the University of Bremen. His research focuses on international commercial law, with a particular emphasis on legal harmonization through both hard and soft law, private international law, and dispute resolution. In addition, he explores the digitalization of law (legal tech) and anti-corruption measures. A frequent speaker at international conferences, Olaf has published extensively, including CISG Methodology (co-edited with A. Janssen, Sellier 2009), The Impact of Corruption on International Commercial Contracts (co-edited with M.J. Bonell, Springer 2015), and Public Policy and Private International Law (Edward Elgar 2022). He is currently working on a new project on the UNIDROIT Principles of International Commercial Contracts in arbitration.

Venus Valentina Wong co-heads the firmwide arbitration practice at Wolf Theiss and is based in Vienna. Valentina is also a member of the firm's Asia Desk. Valentina has particular experience in the enforcement of foreign judgements and foreign arbitral awards.

Valentina currently serves as the alternate Austrian member of the ICC Court of International Arbitration. She teaches at the University of Vienna and at the Austrian Lawyers' Academy and is a frequent speaker at international conferences. Among her numerous publications is the chapter on enforcement under the New York Convention in a handbook on (Austrian) arbitration law and the third edition of a handbook on commercial arbitration covering the jurisdictions in the DACH region which she co-edited in 2024.
